WHEREAS, the Clerk of the Legislature was authorized to advertise for sealed bids for the mowing of Farwell and Five Points Landfills and Kyler Hill Shooting Range for the Department of Public Works, according to specifications provided by the Public Works Committee, and

WHEREAS, the Department of Public Works solicited proposals from two (2) companies for the provision of the aforementioned services, and

WHEREAS, Geiter Done of WNY, Inc., 300 Greene Street, Buffalo, New York 14206, can provide an enclosed van trailer at the Salamanca Transfer Station located at 289 Center Street in the City of Salamanca, and will remove the full trailer and replace with an empty trailer, upon request by the County, for an amount of \$163.00 per ton, with a ten (10) ton minimum, and

WHEREAS, sufficient funds are included in the budget to cover the cost of the aforementioned services, now, therefore, be it

RESOLVED, that the Chair of the Legislature be, and hereby is, authorized and directed to execute a contract, on behalf of Cattaraugus County, with Geiter Done of WNY, Inc., for the provision of the above-described services, for a term commencing June 1, 2023 and terminating May 31, 2025, with the option to extend for two (2) additional one-year terms at the same rates, upon mutual agreement of the parties, according to the above-described terms.

AUTHORIZING THE CHAIR TO EXECUTE CONTRACT WITH VILLAGE OF GOWANDA FOR THATCHER BROOK HAZARD MITIGATION PROJECTS

Pursuant to Section 450 of the County Law.

WHEREAS, Act 442-2022 authorized a contract with the Village of Gowanda, 27 E. Main Street, Gowanda, New York 14070, for the provision of \$75,000 for assistance with the Thatcher Brook Flood Mitigation Projects, and

WHEREAS, since the devastating flood of 2009, the Village of Gowanda has been working on a \$10.7 million federal project to reduce the risk of future flood damage from frequent overbank flooding of Thatcher Brook by the execution of Project Partnerships Agreements with the U.S. Army Corps of Engineers and the NYS Department of Environmental Conservation, and

WHEREAS, as part of the Village of Gowanda's local share of \$1,872,500, it is responsible for land acquisition, easements, rights of way, relocation and disposal area on impacted properties as well as a portion of the construction costs of the diversion channel, and

WHEREAS, the Village of Gowanda is requesting assistance from the County in the amount of \$800,000, which will be used for land acquisition, easements, rights-of-way, relocation and disposal areas for all 28 impacted properties, and

WHEREAS, the County shall pay to the Village of Gowanda an amount of \$800,000, to be paid as invoiced, and

WHEREAS, this project is 65% federally funded through the Army Corps of Engineers (\$6,954,000) and a 35% split between the NYS Department of Environmental Conservation (\$1,872,500) and the Village of Gowanda (\$1,872,500), and

WHEREAS, the Village of Gowanda has been promised \$1,000,000 through a DASNY grant, which will be paid upon the Village spending \$872,500, and

WHEREAS, sufficient funds are provided through Casino funds to cover the County's \$800,000 contribution to the Village of Gowanda, now, therefore, be it

RESOLVED, that the Chair of the Legislature be, and hereby is, authorized and directed to execute a contract, on behalf of Cattaraugus County, with the Village of Gowanda, for the payment of \$800,000 in funding to the Village of Gowanda for the Thatcher Brook Hazard Mitigation Projects, for a term commencing January 1, 2023 and terminating December 31, 2025, according to the above-described terms, and be it further

RESOLVED, that the County Administrator is hereby directed to use Economic Development Funds through Committee Fund Balance Account ED.913.0000 to fund the above-described project.¹

AUTHORIZING SUBMISSION OF PUBLIC COMMENT TO NYS DEPARTMENT OF ENVIRONMENTAL CONSERVATION SOLID WASTE MANAGEMENT PLAN

Pursuant to 6 NYCRR Part 360.

WHEREAS, the Cattaraugus County Department of Public Works has reviewed the New York State Solid Waste Management Plan, and

WHEREAS, the plan, as submitted, sets unattainable goals which tend to drive aggressive regulations that can adversely impact local government units, and

WHEREAS, a surcharge on all waste landfilled or combusted, known as the "per ton disposal disincentive charge", will drive up disposal costs and incentivize illegal dumping, and

WHEREAS, the "circular economy" concept, a model of production and consumption that involves sharing, leasing, reusing, repairing, refurbishing and recycling existing materials and products for as long as possible, is supported by staff; however, municipalities are noticeably excluded from financial inclusion in the reimbursements from manufacturing and/or funding from the state, and

WHEREAS, New York State places a dependence on municipal participation through "unfunded mandated" services such as source separation policy, and

WHEREAS, in 2022, the County's collection sites received 117,622 pounds of electronic waste, and

WHEREAS, as of January 1, 2023, the State requires that the County no longer charge for the handling of electronics, and

WHEREAS, the cost for labor and benefits alone is estimated at \$79,000.00 to collect that volume of E-waste all at County/taxpayer expense, and

WHEREAS, the extended producer responsibility (EPR) is a mandatory form of product stewardship that places the primary financial and managerial obligation for the environmentally responsible end-of-life management of a product on its manufacturer and shifts the financial burden away from municipalities and taxpayers, and

WHEREAS, the above-described EPR is supported by staff; however, the scope is not broad enough for a ten-year plan, and

WHEREAS, waste derived from renewable energy sources, such as solar, wind turbine, electric vehicle batteries, etc., is noticeably absent from the plan, and

WHEREAS, by the year 2030 there will be 10 million tons of solar waste in the United States and 78 million tons globally by the year 2050, and

WHEREAS, the State plan, as proposed, is not sufficient to sustain the ten-year period it is intended to cover, and

WHEREAS, local municipalities seek guidance from the regulators for the proper management of hazardous waste; this plan does not provide for that need, and

WHEREAS, source reduction is defined as the elimination of waste before it is created and involves the design, manufacture, purchase or use of materials and products to reduce the amount of toxicity of what is thrown away; and the Plan, as proposed, does not require the responsibility for product toxicity, recyclability, and planned obsolescence to reside solely with the manufacturer, and

WHEREAS, the Plan does not do enough to emphasize source reduction as a strategy, and WHEREAS, this Plan does not address the reduction of contaminants in photovoltaic panels that contain chemistries that include PFAS (per- and polyfuoroalkyl substances) and other hazardous materials or the end-of-life takeback, and

WHEREAS, this Plan does not appear to address access to markets for rural and disadvantaged communities, and

WHEREAS, municipalities remain providing services at taxpayer expense without accessible markets, and

WHEREAS, many rural municipalities do not have the capacity for the volumes of recyclable material that have no market, and

WHEREAS, the plan does not address the ecosystem impact of renewable energies, and WHEREAS, disposal or recycling of electric vehicle (EV) batteries is not addressed, and

WHEREAS, being a primary part of the chemistry for photovoltaic cells, wind turbines and EV batteries, are not addressed, now, therefore, be it

RESOLVED, that the Cattaraugus County Legislature here submits to the New York State Department of Environmental Conservation, Division of Materials Management, Bureau of Solid Waste Management, the above-described public comments for consideration, and be it further

RESOLVED, that the Clerk of the Legislature be, and hereby is, directed to forward copies of this resolution to Senator Borrello and Assemblyman Giglio, and all others deemed necessary and proper.

WHEREAS, for more than two (2) years, many residents in long-term care facilities have been separated from their loved ones – far too many lost their will to survive, and many others have suffered untold and irreversible emotional, psychological and physical pain as a result of this separation, and

WHEREAS, it is vital that we as a society realize the critical role that family members and caregivers play in the support and well-being of residents in long-term care facilities, and

WHEREAS, this Bill will ensure that in any future public health emergency, designated essential caregivers will have their access to their loved ones protected in a manner consistent with all applicable health and safety protocols, and

WHEREAS, this Bill further safeguards a resident's civil rights and other rights under Federal Law while taking into account public health concerns, now, therefore, be it

RESOLVED, the Cattaraugus County Legislature does hereby strongly support the Essential Caregiver Act introduced as H.R. 3733, and be it further

WHEREAS, the estimated impact to Cattaraugus County is \$2,175,544, and

WHEREAS, counties are already struggling under out-of-control state mandates and Governor Hochul's plan to raid Medicaid funds will leave counties with a choice of cutting safety net services or significantly increasing property taxes, and

WHEREAS, according to the New York State Association of Counties (NYSAC), the Governor's plan may result in a property tax increase estimated at 5% to 10% at a time when inflation and gasoline prices are already crippling middle-class families, and

WHEREAS, it is hypocritical of the State to impose a property tax cap and then push massive New York State mandated costs onto the counties, and

WHEREAS, the Protect Local Taxpayer's Act will prevent the state from further shifting Medicaid expenses onto local county governments, and

WHEREAS, counties have used these federal funds over the past 20 years to pay for local services and reduce property tax burdens in our communities, as intended by Congress, and

WHEREAS, while the Governor purports to help low income counties, the elimination of FMAP funds will have a devastating effect on Cattaraugus County and its residents, now, therefore, be it RESOLVED, that the Cattaraugus County Legislature strongly supports Congressman Langworthy's Protect Local Taxpayers Act introduced as H.R. 2600, and be it further
