WHEREAS, the New York State Unified Court System shall reimburse the County an amount of \$131,527.75 for the cleaning of court facilities, repairs and maintenance for the period April 1, 2023 through March 31, 2024, now, therefore, be it

RESOLVED, that the Chair of the Legislature be, and hereby is, authorized and directed to execute a contract, on behalf of Cattaraugus County, with the New York State Unified Court System for the provision of the above-described services and to accept reimbursement funds, for a term commencing April 1, 2023 and terminating March 31, 2024, according to the above-described terms.

WHEREAS, the County Department of Public Works is desirous of applying for the aforementioned planning grant funding to develop a Comprehensive Safety Action Plan, and

WHEREAS, the Comprehensive Safety Action Plan will identify safety improvements, programs and strategies to reduce by 50% the number of fatal crashes and serious injury crashes by 2050 with an eventual goal of eliminating roadway fatalities and serious injuries, and ¹

WHEREAS, this grant is 80% federally funded (CFDA #20.939) and 20% County match, now, therefore, be it

RESOLVED, that the Cattaraugus County Legislature concurs and supports the goals identified as part of the 2023 Safe Streets and Roads for All (SS4A) grant application, and be it further¹

RESOLVED, that the Chair of the Legislature be, and hereby is, authorized and directed to execute a grant application, on behalf of Cattaraugus County, with the U.S. Department of Transportation, in order to apply for the USDOT Safe Streets and Roads for All funding, according to the above-described terms, and be it further

RESOLVED, that upon termination of either state or federal funding for this program, then this program shall be automatically abolished, and be it further

RESOLVED, that such contract shall provide that upon the reduction of any such funding, the County, in its sole discretion, may terminate the contract on thirty (30) days' written notice, and be it further

RESOLVED, that in the event of any such reduction, the department head involved shall immediately report such occurrence to the Chairman of the Committee to which the department is assigned, who shall add the matter to the agenda of the Committee's next meeting.

WHEREAS, this legislation has been couched as a savings to municipalities but fails to consolidate all local offices since it does not accompany a constitutional amendment to change the terms of constitutional positions; since at least one election will be held in the odd numbered year, all election infrastructure will need to be in place, thereby removing any potential savings, and

WHEREAS, this proposal removes local control and places a new unfunded mandate on the municipalities; this legislation, at the very least, should have been at local option, and

WHEREAS, this legislation was passed with no public hearing, no engagement with local elections commissioners and other stakeholders, and opts out the largest municipality, New York City, from having to comply, and

WHEREAS, the Cattaraugus County Legislature therefore wishes to express its opposition to this poor election policy and unfunded mandate, now, therefore, be it

RESOLVED, that the Cattaraugus County Legislature hereby urges Governor Hochul to veto A.4282-B and its companion legislation S.3505-B, which will have dramatic and negative effects on the local election cycle, and be it further
