WHEREAS, as part of the NYSDEC environmental screening and permitting process, a freshwater mussel survey is required at the project site, and

WHEREAS, CHA Consulting, Inc., shall subcontract with Environmental Solutions & innovations to perform the required freshwater mussel survey for an amount of \$27,500.00, and

WHEREAS, a contract amendment is necessary in order to include the aforementioned freshwater mussel survey and extend the termination date to June 30, 2024, and
